While the work we do is serious, there's a joy and fulfillment in making an impact in people's lives.

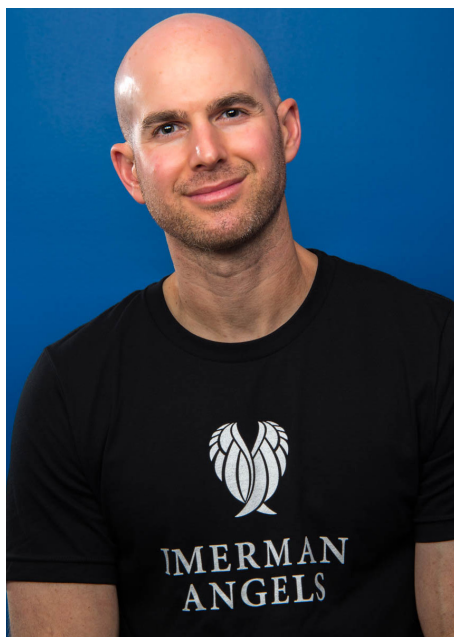
STAY INNOVATIVE AND ALWAYS IMPROVE
